## Laura Cox Seeks State GOP Post



Laura Cox, two-term state rep, former Wayne County commissioner and U.S. Customs special agent, all describe the Eastside Republican Club speaker for 7:30 p.m., Tuesday, Jan. 15, at the War Memorial.

Now, the logical question: "What's next?" These days, Cox is campaigning for leadership of the Michigan Republican

Party.

Also seeking the post is Pontiac native Gina Barr, a longtime GOP activist and former RNC staffer.

"Laura Cox is a woman with a long record as a fighter for sound government, and has raised a family that values our country's freedoms. Laura's daughter is a U.S. Marine who served in Fallujah, and one son is currently a Naval Academy midshipman," said ERC chairman Dr. Annette DeSantis Feldpausch in a statement.

"The Forum is open to the public at no charge, so we invite anyone interested the future of the GOP in Michigan to hear from Laura and ask questions," Feldpausch added.

Forum doors open at 7 p.m. for coffee and networking in advance of the meeting.

ERC members will 2019 elect officers and board members at the January 15 meeting.

As GOP activist, Cox served as district chair and state committee member. She also served as delegate to the 2012 Republican National Convention.

In 2014, Cox was elected to the Michigan House of Representatives representing her Livonia district. After winning election to her second term, she was named the first female House Appropriations chair in the history of Michigan, helping to oversee a \$56 billion budget.

Prior to serving in the legislature, Cox won election as the only Republican on the Wayne County Board of Commissioners, where her colleagues selected her as chair of the Ways and Means Committee. As commissioner, Cox championed transparency in government and was the first to make her office budget available online.

Cox began her public service as a U.S. Customs special agent where she worked undercover, conducted surveillance, and executed search warrants to stop drug traffickers. During 13 years as an agent, her work also included sophisticated financial investigations to halt smugglers and currency traffickers.

She earned a bachelor's degree in criminal justice from Michigan State University, and a master's degree in criminal justice research and planning.

Cox and her husband, former Michigan Attorney General Mike Cox, have four children and two grandchildren.

# **ERC Board Elections Set for January Meeting**

Eastside Republican Club members will elect 2019 officers and board members at their regular meeting, Tuesday, Jan. 15, 2019, at the War Memorial. The meeting will be called to order at 7:30 p.m.

Only regular ERC members current in dues are allowed to vote. Members will make nominations from the floor.

As provided by the bylaws, "All seven members of the Eastside Republican Club executive board shall be elected at the Annual Meeting by plurality vote of the Regular Members present and voting. Voting by proxy shall not be allowed."

Offices are chair, vice chair, secretary and treasurer. There is no term limitation on the four elected officers, and they may succeed themselves in office.

The board includes three at-large members. No board member may serve more than one term as an at-large executive board member during any two-year period.

Any member with a question about the responsibilities of a specific office or position is encouraged to contact chairman Annette Feldpausch or other officer.

## Haroutunian Appointed To Redford District Court Bench



Krista Haroutunian was recently appointed to the 17th Judicial District Court, Redford Township. Formal investiture ceremonies were held Dec. 3, 2018, in Redford.

Former Michigan Court of Appeals Judge and Michigan AG Bill Schuette addressed the investiture assembly.

Judge Robert Columbo of the Third Circuit Court, Wayne County, administered the oath of office.

Judge Haroutunian has been in private practice as a shareholder with the firm Haroutunian Licata Haroutunian, PC since 1998 where she focuses on probate, estate planning, family law, and real estate matters.

Since 2013, she has served as a special assistant Attorney General with the Michigan Department of Attorney General, handling contested guardianship and conservatorship petitions for the Audit Protective Services Division of the Department of Health and Human Services.

Judge Haroutunian is a member of the State Bar of Michigan, serving on the Board of Commissioners since 2015. She is also a member of the Detroit Bar Association, the Oakland County Bar Association, the Wayne County Probate Bar Association, the Wayne County Family Bar Association, and the Armenian American Bar Association.

She is on the board of the Armenian Relief Society and has been a member of the Michigan Women's Commission since being appointed in 2011.

Judge Haroutunian earned a bachelor's degree from the University of Michigan in 1993 and a law degree from the Detroit College of Law at Michigan State University in 1998.

She fills the vacancy created by the resignation of Judge Charlotte Wirth. For a full term, she must seek election in November 2020.

## MIGOP Leadership Changes in February

MIGOP chair Ron Wieser convened his final MRP State Committee session of his twoyear term in December 2018. Wieser's term officially ends



after a new chair is elected at the MRP Convention in Lansing in February.

Though he would be the first to express disappointment with the November election, he reported that several building blocks are in place for

2020, and highlighted the importance of maintaining a legislative majority in Lansing.

The MRP staff Wieser assembled is considered one of the finest in the U.S based on efforts in social media, data development and candidate support.

In February, Congressional District delegates will convene in Lansing to select new leadership at both the District and State levels.

Presently, two candidates have announced their run for MRP Chair:

- Laura Cox (Livonia)
- Gina Barr (Pontiac)

Whomever is elected as State Party chair will have the opportunity to lead the Michigan GOP team and raise funds necessary to re-elect Pres. Donald J. Trump.

You are invited if you are a precinct delegate elected at the Aug. 7, 2018, Primary Election. We'll meet at 7 p.m., Thursday, Feb. 7, 2019, at Grosse Pointe Library Woods Branch Meeting Room (downstairs), 20680 Mack Ave.



Purpose of the meeting will be to elect the Wayne 14th executive board (chair, vice-chair, secretary, and treasurer), as well as our delegates and alternates to the Feb. 23 State Republican Convention at the Lansing Center.

In that regard, I have served as chair of the Wayne 14th since 2013, and am happy to announce that we have someone eager to take over the Wayne 14 helm from me—Monica Palmer of the Woods!

All organizations are better when leadership rotates among its ranks, so I will be running for vice-chair to assist her with the transition and new responsibilities.

## **ERC Forum Focused On Affordable Energy**

Jason Hayes, environmental policy director for the Mackinac Center for Public Policy, talked to the ERC on Nov. 20 about both electricity deregulation and the value of affordable, reliable energy to human wellbeing.



He carefully explained the factors driving costs,

including external forces such as the environmental movement, and Michigan's rate-setting process for its fully-integrated electric monopolies.


Hayes made clear that when considering costs, one must consider the cost of taxpayer subsidies.

He explained that Michigan electricity prices are higher than either U.S. or the Great Lakes states and are surging. In addition to the higher cost, he pointed out that Michigan's electricity supply is the least reliable.

Hayes talked about the "intermittency" of wind and solar vs. the reliability of today's "dispatchable baseload technologies."

Hayes graciously answered audience questions and remained afterward to engage in one-on-one dialogue.
